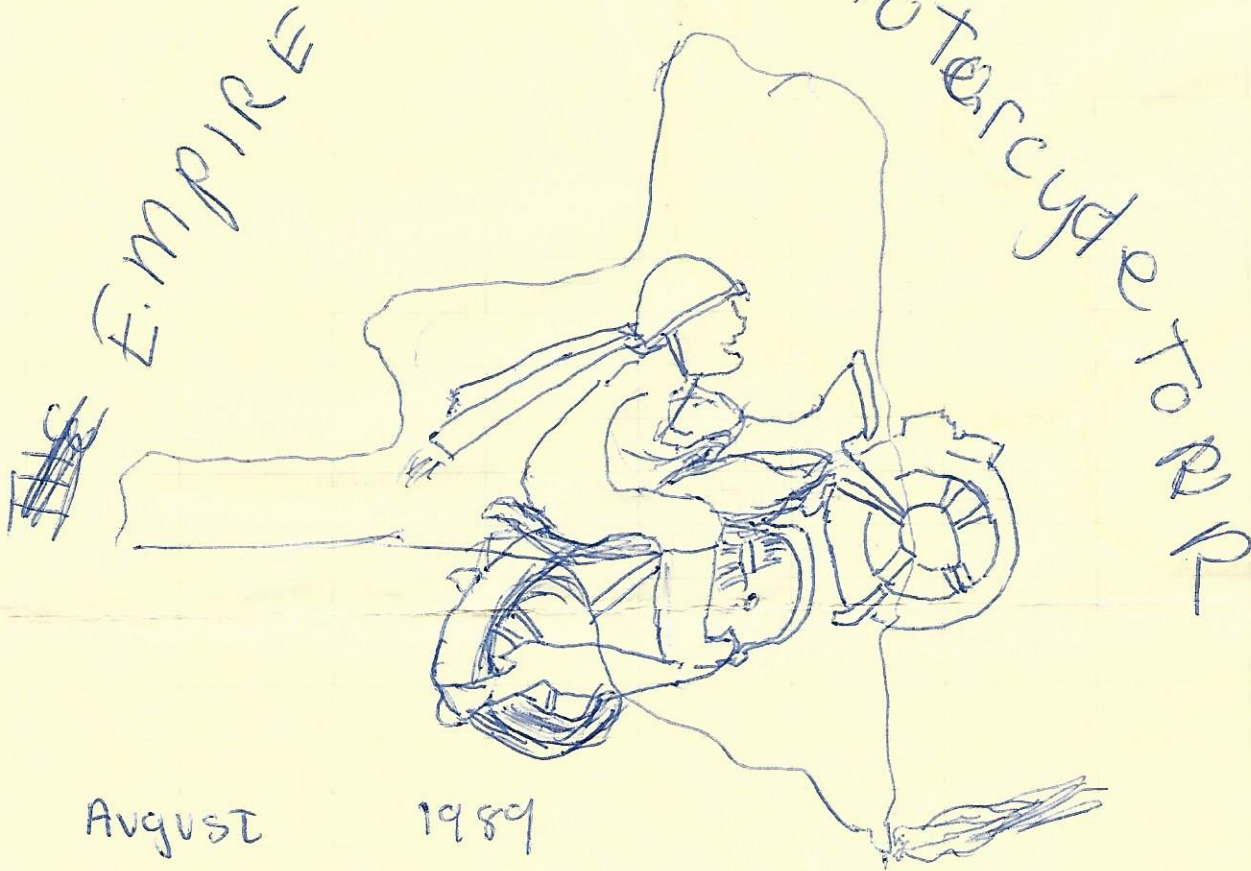

The President had no report.

Emil submitted the treasurer's report in writing, and it is herewith enclosed.

ROAD CAPTAIN'S REPORT:

José reported a very good turnout for brunch and the Bike Show at the Javits center. 14 people were in attendance including 4 members of the Bucks, 2 T-Bolts and the rest from ECMC and GDI. A number of the attendees also went to see "Forbidden Broadway" later that evening. The bike show was considered to be fairly poor by all who expressed an opinion.

José also expressed his thanks to Mark for filling in for him at the last bar night.

CORRESPONDING SECRETARY'S REPORT:

Jim reported that the mail was picked up from the PO Box on Sunday, March 4, and was passed around at the meeting for all to peruse.

RECORDING SECRETARY'S REPORT:

Bob expressed his apologies for missing the last meeting. He would also like to express his appreciation to Emil for preparing the minutes for the Feb. 22, 1989 meeting.

COMMITTEE REPORTS:

RIDE/RUN: While ordering the run pins, George got prices for decals which can be placed on drinking glasses/mugs. The idea was not met with much enthusiasm and there was no further discussion.

José brought up the fact that we need to finalize prices for the run. Our costs for the food and lodging are \$117/person for a 2 night stay, and \$156/person for the full weekend. It was agreed by the committee that members of Empire City should pay for their own run fees. The committee had felt that any overage from the run fees be given back to the ECMC members as a rebate, but after some discussion it was realized that after advertising, printing, beer, etc. that there would be no overage.

A motion was made to set the run fees at \$125/person for a 2 night stay, and \$160/person for the full weekend. This passed unanimously.

The ride committee needs to meet as soon as possible to finalize the pricing for the ride. Members are asked to contact Jose to set up the next committee meeting.

BIKER'S PICNIC: Emil gave Bob a check for \$100 for the purchase of postage stamps for mailing the Christening/Picnic fliers. Mel will have the fliers ready by the next meeting.

Bob will bring the envelopes, and George will bring the mailing labels, so be ready to fold and stuff at the next meeting.

All members are reminded that the committees are open committees, and that all members are welcome at any of the committee meetings.

OLD BUSINESS:

MEMBERSHIP: The possible Pledgeship of Ken Lancaster was discussed. Sponsors are Jim and Bob. Jose has ridden with Ken many times, and confirms that Ken has a valid motorcycle license. Emil mentioned that he has still not gotten his Treasurer's rocker from Bill.

Mark made a motion to investigate the costs and feasibility of getting business cards printed up with the club Logo and mailing address. Second by Bob. After some discussion the question was called by Jose, and the motion passed by a vote of 7-0-2. Bob said he would check with a local printer that he used at work for prices.

Keith, Emil, Bob, and Jim were present at the T-Bolt's installation dinner. The group was authorized to buy after dinner cordials for the attendees if they thought it prudent, but since there were over 80 people in attendance it was considered too expensive so we did not provide cordials. George made a motion to increase the amount we had allocated for the open bar at the T-Bolts cruise run from \$100 to \$150 (an increase of \$50). Second by Cliff. Josè suggested that we not stay at a motel in West Point on Friday, August 25, but ride all the way to New York and sponsor a barbecue/party at Ken and Josè's house. The barbecue will be for the Tour participants, and guests from area clubs will be invited to the party afterward. Ken and Josè can also provide accommodations for our out-of-town participants who wish to stay over and start home fresh on Sat. morning. Since many of the club members will be on the Tour, it was decided that we should have the barbecue catered.

EMPIRE STATE TOUR (cont):

Food costs: We will be providing some sort of breakfast to all the participants each morning of the tour. At some locations this will be a full breakfast while at others it will be a continental breakfast. We are computing breakfast costs at \$5/day/person, so the breakfast component of the food cost will be \$40/person for the Tour.

** NOTE: there are only 7 mornings on the Tour, so the breakfast costs will be \$35/person

We will have a small banquet room at the Holiday Inn for arrival, which will be stocked with sandwiches and cold cuts until 1 am so that our late arriving guests can get something to eat. The cost of the hospitality is \$7/person. Dinner will be provided on Saturday August 19 at a cost of approximately \$25/person. Dinner will also be provided on the boat tour of Seneca Lake on Tuesday August 22 at a cost of approximately \$35/person which includes the boat ride ticket. The boat tour starts at 7pm and runs between 3 and 3.5 hours. The barbecue at the conclusion of the Tour is estimated at \$20/person.

The possibility of everyone getting together for brunch on Sunday at Bellhess Castle (sp?). It was decided that we wanted another event that everyone would participate in, and that after the long ride on Saturday it would be nice to get up a little later and do a group brunch. Brunch could be completed by a reasonable hour in the afternoon, leaving the rest of the day for the participants to partake of whatever activities they wished. The brunch would cost approximately \$9/person.

This would bring total food costs to:

Since taxes, tips, hospitality rooms, advertising, run pins, and other expenses are not included, it was decided that the advertised cost of the Tour would be \$310. Raising the fee to \$325 was discussed, but it was decided that we would get much less participation at that price. It was made clear to those present that the club may wind up subsidizing the Tour for up to a thousand dollars.

It was suggested that for the breakfasts that we use a ticket system, and that the tickets clearly state that tip is not included. Taxes and tips for the organized dinners will be paid by the club. Cliff inquired about tips for the Housekeepers at the various hotels, and it was decided that those kind of tips were up to the individual. It was felt that it would be proper to mention such practices in the Tour Guide.

The flier for the Tour is almost ready for printing, and it was decided to limit the mailing to those on our mailing list who own motorcycles. The flier/application will have a complete liability disclaimer and release, and will state a limit of 30 participants. It was felt that if we had a lot more than 30 people express interest, we would inquire with the hotels if we could expand the group.

Emil gave Josè 2 blank checks to cover deposits for the Watkins Glen and Cooperstown motels. The Holiday Inn reservation is guaranteed by Josè's credit card. Josè will report to Emil the exact amount of the checks.

Josè will be contacting members in order to get their help in making phone calls to arrange/get information on the various activities that will be available during the tour. Please contact Josè and help out with the arrangements. This is something that everyone can help with.

George said that he has ordered kickstand supports for the participants, and that he will be underwriting their cost.

Keith said that he will underwrite the cost of caps for the tour participants. It was estimated that the caps would cost about \$4.75 apiece for the 3-color printing.

If we all help, then all will go smoothly. Also, please note that New Jersey Law requires that garbage be separated for recycling, so make sure that the right items are going in the right cans.

Keith has made reservations at the Mercer Museum in nearby Doylestown for Sunday afternoon for those people who wish to take the ride out and visit. There is also a Tile Works at the property which may be an interesting tour. Keith will schedule a tour of the Tile Works for Sunday afternoon as well.

There will also be a ride/tour through some very interesting roads in the country that will not stop at the museum and tile works for those who just wish to ride.

Bike Christening:

So far we have confirmed for the Christening: 2 Rochester Rams, a new arrival from LA, 5 ECOM members (Bob, Ken L., Charlie, Mark, Mel), Bill Bratton, 3 T-Bolts, making 12 bikes confirmed already. José will be speaking to the Bucks shortly to see if they have any bikes coming, and will also talk to the Spartans to see if they have any coming. It is expected that we could easily have 15 bikes this year, breaking all previous records, as there are 2 clubs we haven't heard from, and we generally get 3 or 4 walk-ins that night. The previous record is 14 bikes.

For the christening itself, Jim will be co-ordinating "pulpit supply." It was felt that Jim could handle the ministerial duties himself, as Father Tim Marshall had been contacted and was unable to participate due to family obligations, and it was decided not to invite a certain member of clergy again, due to some political goings-on.

There will also be a "blessing of the bikes" for another safe riding season immediately following the christening, to be held outside.

MINUTES OF THE MAY 10, 1989 MEETING

Empire State Tour:

So far 3 members (George, Keith, and José), and 1 other person have confirmed for the tour. Cliff is unable to attend due to work considerations, and Emil will be unable to attend as his company will be changing locations at that time. Bob has reprinted and mailed all the flyers for the tour. José is working on the tour materials for the attendees, and will be producing a questionnaire so that we may better tune the activities available to the interests of the people attending. The questionnaire should be ready by the next meeting.

25th Anniversary Run:

The run flyer needs to be done as soon as possible. Other clubs who are having events around the same time already are getting their flyers out, so we have to get out there and compete for people's time and money.

Keith has been plugging our run, and has made announcements at 3 other runs

There was some discussion about doing our run flyers in color, but the cost is somewhat prohibitive. It was then thought that we could print the flyers on colored paper, representing the fall foliage colors. The ideal paper would be a "mottled" colored paper, but if that's not feasible we could re-print the flyers on various solid colored papers that represent the fall colors. Bob will investigate the availability of colored papers at printers local to him. Other members are requested to check the availability of colored papers for the flyers.

Cliff thought of using a biker throwing a lasso, and José added that the lasso should be in the shape of the logo. The biker then wound up on a bike (of course), and the possibility of including a "boot-licker" going over the biker's boots was proffered.

OLD BUSINESS:

Excelsior Friendship Fair:

Excelsior called Bob to confirm our booth at their Friendship Fair to be held at the Spike on May 20th (Saturday). They will reserve an area large enough for a motorcycle just inside the corner door. George, Mark and Keith will be bringing their Polaroid cameras for the event. There will be several bikes there (one of which can be brought inside) and Charlie has confirmed that he will be bringing his bike with sidecar, which will be available for pictures outside. The event starts at 6pm, and the Spike will be open for setup at 4:30. Members who are participating are requested to arrive by 5pm. REMINDER: Bring some leather accessories which we can rent out for the picture taking. Emil will attend in order to collect the money. Emil will see if he can print up some tickets, so that the money collection can be centralized and controlled, and will provide receipts for the "customers."

Run Pins:

When George called to inquire on the status of the pins, he was told that the caps were not ready yet. Apparently, the place where Keith ordered the run caps does their business with the same printer who is doing the pins.

George found 2 boxes of them in his travel trunk (which he got from Jim in Montreal) right next to his riding gloves from that rainy weekend which are now a certified science project. (I wonder if you can get penicillin from leather?)

"Gay bike club" questionnaire:

Many members expressed some concern about the questions asked, and their personal and sexual nature. George moved that we not answer the questionnaire as we had no control over what was done with the information provided. The motion was seconded by Cliff. The motion passed unanimously.

Aids Walk NY:

The AIDS Walk - NY will be held on the 21st. The club had previously moved to donate \$100 for the walk to be split evenly among how ever many members of the club who were walking. At this time, Mark and Charlie are registered for the Walk, and Emil was requested to issue 2 checks in the amount of \$50 each, payable to AIDS Walk - NY. Both checks were cut, Mark received his, and Charlie's check will be mailed to him by Emil.

NEW BUSINESS:

Hartford Colts request AMCC membership:

The Hartford Colts are interested in becoming members of the AMCC, and have indicated that they would really prefer if we would sponsor them for membership. Keith reported that they met the 10 member requirement, and that they have been represented at just about every run he's been to in recent memory. Bob moved that we sponsor them for membership, seconded by José. After some discussion, Bob amended his motion to include that the executive committee will check their constitution, and that if all is ok that we will sponsor them. The amendment was accepted as friendly by the second. The motion passed unanimously. Keith suggested that we send a letter to the AMCC president, sponsoring the Colts, as soon as their constitution is reviewed and found acceptable.

Wheels Run:

At our last bar night, Keith was approached by a member of Wheels and asked if we wanted bike events. Keith turned to Bob and asked the question, and he responded "sure!". The Wheels member then said if we wanted bike events, then our Road Captain will have to do them.

Wheels is also going to be doing their show from the run "in-town" at a local theatre during the week leading up the Picnic, and that weekend as well.

MINUTES OF THE MAY 10, 1989 MEETING

GOOD AND WELFARE:

Emil distributed an article from the AMA magazine regarding National Health Insurance and the possibility that this will require motorcyclists to buy additional health insurance at a very high price due to participating in a "high-risk" activity. Cliff mentioned that he had heard that some company was planning on doing the same thing, and that it is probably illegal under current law that requires that group insurance cannot treat members of the group differently.

José reported that he has been talking to the Gay Pride Parade committee about the men riding their bikes in the parade with the women. The committee has so far offered that we could ride behind the women, and José told them that was unacceptable and that the bikers should be one group, regardless of sex. Riding at the head of the leather delegation was discussed, but it was felt that we belonged at the head of the parade with the women bikers. The Parade committee will be discussing this further, and will get back to José with their decision.

Mark announced that he has completed his educational requirements to be a Certified Alcoholism Counselor (CAC), and that he is preparing for the examinations for that certification. He also announced that he sold his old bike, and that he has bought a new BMW K75, which is just waiting for accessories to arrive and be installed before delivery.
