





# **An Important Note to Donors**

Although we take the greatest pains at all times and in all respects to ensure that the greatest percentage of donations remains with the cause, we cannot make any guarantees about what that percentage will be. There are variables we cannot predict that prevent that – like how many people ultimately participate, and how much money each of them raises. The more people that participate, and the more money raised, the greater the percentage that can remain with the cause.

# How much money has gone back to the cause?

Since our first event in 1994, Pallotta TeamWorks' events have netted an astonishing \$154 million for AIDS and breast cancer charities. The AIDSRides, in seven years, have channeled over \$83 million directly to AIDS charities. The Avon Breast Cancer 3-Days, in three years, have put over \$65 million directly into the hands of breast cancer charities. # How do our percentages compare with other fundraisers' percentages?

The National Society of Fundraising Executives recommends that no more than 50% of a donor contribution go toward expenses. Pallotta TeamWorks' average event expense percentage of 40% is well below that threshold. In the State of California for the year 1998, according to the Attorney General's report, only 44% of every charitable dollar donated through commercial fundraisers actually went to charitable services. Pallotta TeamWorks' average of 60% is well above the actual state average.

# How do Pallotta TeamWorks' events compare with other events?

Our events do two things at once. First, we are putting on a fundraiser. Second, we are providing a life-changing, transformational type of experience for each individual who participates. When you consider that, even after doing two things at once, our percentages exceed industry standards, you get a true sense of just how efficient our operations are.

A typical charity walk-a-thon lasts half a day. In order to provide a life-challenging experience, and an experience that inspires people to donate at the volume they do to our events, you have to do something much more epic than that.

A typical Pallotta TeamWorks event lasts four days, and includes 3,000 participants. # EMPIRE CITY MOTORCYCLE CLUB BIKER'S PICNIC SURVEY REPORT

# BACKGROUND:

Partially as a result of the poor attendance at the 2001 annual Biker's Picnic, but also to analyze the views of the current Empire City M.C. membership, a "Biker's Picnic Committee" (the Committee) was formed to review this event. In light of the role that the Biker's Picnic has played as an annual ECMC tradition through its 38 years as an organization, the Committee felt that it was essential to ascertain the views of all the membership on this issue. A survey was drafted as the means to obtain the opinions of the membership on the Biker's Picnic.

# THE SURVEY:

Drafted by the Committee Chair and reviewed by the current President and Road Captain, the survey consists of five fairly direct questions. While simple the questions were designed to elicit more than just yes or no responds and the extend to which members choice to expand on their answers was left to the individual. This was not a confidential survey and it was gratifying to note that close to half of the respondents actually identified themselves as part of answering the survey or by signing their names.

# **SUMMARY OF KEY SURVEY RESULTS:**

The following highlight the keys points noted in the of the survey:

- > A total of 20 surveys were distributed;
- > 16 or 80 % of the membership responded;
- > Not all respondents answered all the questions;
- > Of the 80 % of the membership responding:
  - 93 % or 15 members wanted to continue holding the Biker's Picnic. The one exception did not addressed the question;
  - o Nearly 70 % (11) of the respondents would like to see changes made with 12 different suggestions made as to how;
  - 50 % (8) of the respondents would like to continue having the Biker's Picnic during Memorial Day weekend
  - 43 % (7) of those responding wanted a weekend other than Memorial Day weekend, with five members offering suggestions;
  - O None of the respondents wanted just a one day event;
  - 61 % (10) of the respondents suggested that various changes be made in what is done during the Biker's Picnic with nine
     (9) options named;
  - o 50 % (8) of the respondents had some issues/comments to make and nine (9) suggestions/issues were named.
